How it Works ?

- Enter employee e-mail account into EMPLOYEE MASTER.
- From E-MAIL Payslip module, enter e-mail subject line & setup SMTP e-mail detail. You may attach additional documents such as PDF files, Ms Words or Ms Excel documents.
- Click SEND E-MAIL button !

FREQUENTLY ASKED QUESTIONS (FAQ)

Q) How do we setup e-mail payslip in QUICK PAY ?

First, enter employee e-mail accounts into EMPLOYEE MASTER records. Then, goto E-MAIL PAYSLIP module, and configure your SMTP e-mail server setting and payslip format preferences. Finally, click SEND button to view and send e-mail payslips to your employees.

Q) Can we send e-mail to HotMail.com, Yahoo.com, Gmail.com, etc ?

YES ! You may send email to your own corporate e-mail servers, and also other popular public e-mail hosts such as Yahoo.com, Gmail.com and HotMail.com.

Q) Can we attach & e-mail documents such PDF, Ms Words, and Ms Excel ?

YES !

Q) Can we attach company logo into E-Mail Payslips ?

YES !

Q) Can we request a "receipt" for all e-mail sent ?

YES ! You need to enable option "Request Read Receipts".

Q) Can we keep a CC and BCC copy of all e-mail sent ?

YES ! You need to specify an e-mail account into "CC E-Mail" or "BCC E-Mail" fields.

Q) Can we choose language either in ENGLISH or BAHASA ?

YES !

Q) Is the email encrypted for security purposes?

Yes, user can choose to encrypt with password using IC number, Hire Date, EPF number, Tax number, or birth date. Encrypted file is stored as PDF password protected attachment.

Q) What type of PDF encryption used?

PDF is encrypted using Acrobat 5.X version (encryption 128bit RC4).

Q) Do we need to pay annual maintenance fee for this Module ?

NO ! Annual maintenance fee are NOT required.
